Late Pre-registration

This provision has been made by the ECHA for the first time manufacturers and exporters. This provision; available from the 5th Jan' 09 on the ECHA's REACH-IT portal on a continuous basis shall enable the industries that shall be exporting for the first time to Europe to submit their Pre-registration. The late Pre-registrants can also take advantage of the extended Registration deadlines within REACH.
